#### **CALL TO ORDER:**

At 6:00 pm Mr. Tomaino called the public hearing and town board meeting to order with the pledge of allegiance. The purpose of the public hearing is to hear any questions or concerns on Local Law A-2025, A Local Law Overriding the Tax Levy Limit.

With no public comment, Mr. Tomaino will continue the public hearing along with the regular meeting.

Discussion on the last income survey that was done in 2019, income surveys are good for 5 years. Mr. Clark will reach out to G&G Municipal Contracting for a quote, the Town has used G&G in the past. Mr. Clark does suggest the Town start this process before the end of the year as the report will be needed by May 2026.

Mr. Tomaino and Mr. Clark had a conference call with the EPA (Environmental Protection Agency) on the STAG grant (State and Tribal Assistance Grant) that was awarded in 2024. The award was for \$1.75M, it was an encouraging call as the agency that holds the funding does not see a problem that there has been a change in the transmission of the sewage. With any federal funding a NEPA (National Environmental Policy Act) needs to be completed before discussions on what the grant can be used for. Mr. Clark will get the NEPA form updated, more information will be coming. Mr. Donegan asked if it could be used to pay down the bond, Mr. Clark responded that it is a possibility.

#### **PARK AND RECREATION:**

Mrs. Zehr told the board that they will be holding trunk n treat again at the park on October 26<sup>th</sup>. As requested, the park summer applications have been reformatted to include the hold harmless statement from Mr. Moran. A big thank you to the highway department for fixing the sign at the park.

#### **HIGHWAY:**

Mr. Whitney reported the following:

- o Paving in Town has been completed; paperwork has been submitted for CHIPs funding.
- O Working on shoulders for the roads that were paved.
- o Buildings have been painted.
- o Firewood is almost completed.
- O Two trucks have been switched over for winter.
- O Paint has been ordered to repaint the historical signs.
- O Working a plan for Mill St.
- o Part time guys will be done next week.
- O National Grid is taking down some dangerous trees on Kibbie Lake Rd.
- O The new grapple has been delivered.

Discussion on updating the wood boiler at the highway garage. The boiler is not working correctly; some areas are hot while other areas are extremely cold. Mr. Whitney reached out to Handy Charlie out of Mexico to give a quote to upgrade the boiler. As the quote is over the procurement policy, it was decided the upgrade will need to be advertised for additional quotes.

The paper describes the different scales of solar energy systems, where they are often sited, and land use considerations. Planning tools and financial impacts on municipalities are also discussed. Language and document examples and templates are provided for use in Tug Hill and other rural communities. The paper is available to read on our website.

- EDA FY25 Disaster Supplemental Grant Program The U.S. Economic Development Administration is making approximately \$1.45 billion available to support economic recovery in areas with major disaster declarations from 2023–2024 events, including hurricanes, wildfires, severe storms, flooding, and tornadoes. Eligible projects must be located in, primarily serve, or benefit affected communities. Funding supports both construction and non-construction projects through three pathways: Readiness (capacity building and strategic planning), Implementation (standalone recovery projects), and Industry Transformation (coalition-led, multi-project regional economic development). Applications for Readiness and Implementation grants are accepted on a rolling basis; Industry Transformation applications are due March 3, 2026.

• **SOCRIS Update:** The Northern Borders Grant application for SOCRIS has been submitted. IMA with the Town of Constantia has been signed by the town and is scheduled for county approval on 9/11 with the IMA Grant application—worth up to \$30 million—to be submitted the following day, September 12. In addition, efforts are underway to schedule a preliminary meeting with the City of Fulton to discuss the framework of an IMA for the treatment of effluent.

• **CiTi BOCES:** Tug Hill Commission Staff Meet with CiTi BOCES Superintendents: On August 6, Tug Hill Commission staff Jillian Lee, Patrick Brady, and Heidi Tompkins met with CiTi BOCES superintendents from nine Oswego County districts. Representatives from NorCOG and SRCG raised concerns about declining participation on town and village boards and the need to engage students earlier in local government. The discussion focused on building civic awareness, developing leadership skills, and creating a pipeline of future local leaders. Superintendents also learned about programs like the NYS Seal of Civic Readiness and the Civic Service Student Activity Program (CSSAP), which provide students with real-world government experience and strengthen ties between schools and communities. Meetings are underway in September to discuss further details.

TOWN OF CONSTANTIA LOCAL LAW NO. A OF 2025

The following resolution was offered by Councilor Moran, who moved its adoption, seconded by Councilor Chapman, to wit:

WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, a proposed local law titled Local Law No. A-2025, "A Local Law Overriding the Tax Levy Limit Established in General Municipal Law §3-c in the Town of Constantia," was presented and introduced at a regular meeting of the Town Board of the Town of Constantia held on August 19, 2025; and

WHEREAS, a public hearing was held on such proposed local law on September 16, 2025, by the Town Board of the Town of Constantia and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Constantia in its final form in the manner required by Section 20 of the Municipal Home Rule Law of the State of New York; and

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law of New York (SEQRA), requires that as early as possible in the consideration of a proposed action, an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, on August 19, 2025, the Town Board declared itself lead agency and determined that the enactment of proposed Local Law No. A-2025 is an unlisted action and will have no significant effect on the environment, issuing a negative declaration, thus concluding environmental review under State Environmental Quality Review Act; and

WHEREAS, it is in the public interest to enact said proposed Local Law No. A-2025.

**NOW, THEREFORE**, it is

**RESOLVED** that the Town Board of the Town of Constantia, Oswego County, New York, does hereby enact Proposed Local Law No. A-2025 as Local Law No. 1-2025 as follows:

## "TOWN OF CONSTANTIA LOCAL LAW NO. 1 OF 2025

# A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-C IN THE TOWN OF CONSTANTIA"

Be it enacted by the Town Board of the Town of Constantia as follows:

## Section 1. LEGISLATIVE INTENT

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Constantia, County of Oswego pursuant to General Municipal Law §3-c, and to allow the Town of Constantia to adopt a Town budget for (a) Town purposes; (b) fire protection districts; and (c) any other special or improvement district governed by the Town Board for the fiscal year 2026, that requires a real property tax levy in excess of the "tax levy limit" as defined by the General Municipal Law §3-c.

# **Section 2. AUTHORITY**

This local law is adopted pursuant to Subdivision 5 of the General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the Town Board.

# **Section 3.** TAX LEVY LIMIT OVERRIDE

The Town Board of the Town of Constantia, County of Oswego, is hereby authorized to adopt a budget for the fiscal year 2026 that requires a real property tax levy in excess of the limit specified in General Municipal Law §3-c.

# Section 4. SEVERABILITY

If any clause, sentence, paragraph, section, article or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operations to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

## **Section 5. EFFECTIVE DATE**

This Local Law shall take effect upon filing with the Secretary of State."
