CALL TO ORDER:

At 6:00 pm Mr. Tomaino called the town board meeting to order with the pledge of allegiance.

PUBLIC COMMENT:

WASTEWATER:

PARK AND RECREATION:

Mrs. Zehr was unable to attend the meeting.

HIGHWAY:

Mr. Whitney was unable to attend the meeting. The highway department has been busy plowing a lot of snow.

COUNTY LEGISLATOR:

Mr. Reehil was unable to attend the meeting. However, Mr. Chapman stated he was advised by Mr. Reehil there is a 5 percent decrease in the County tax rate.

TUG HILL COMMISSION:

Ms. Tompkins gave her monthly report for the North Shore & Salmon Rivers Council of Governments. The Shineman Foundation grant schedule is now available. The next NORCOG meeting will be at the West Monroe town hall on February 26, 2026, at 6:30 pm. The annual training will take place at the Turning Stone on April 20 and April 21, 2026. The communities along the north shore of Oneida Lake are developing a regional community guide to highlight local parks, outdoor assets, cultural features, events, scenic locations, and visitor-friendly activities. A community input survey is available for the guide. Constantia will have two pages to fill in the guide.

TOWN HISTORIAN:

Mrs. Kieffer thanked people who attended the historical marker unveiling at the Bernhards Bay store. The County has banners depicting local historical events that are being loaned to the Towns on a rotating basis. Next year the Town should be obtaining historical markers for Revolutionary War veterans buried in the Town.
